The Facilities Program Management Team works effectively and efficiently to manage the planning, design and construction of over 120 new construction and modernization projects. The expertise of District staff with technical experts from URS seamlessly forms the focused team of professionals that oversees the Facilities Capital Improvement Program currently valued at over \$700 million. This fiscal year, the PMT secured an additional \$363 million in state funding for a total of \$711 million in capital funds secured since 2005. With the first phase of over 40 projects complete, the additional state funding will help pay for the next phase of projects to start at the end of 2008. The next phase includes construction for 1 new high school, 8 special day classroom buildings, and 34 modernizations projects, with the start of design for 3 more modernizations projects, and design completion and land acquisition activities for 8 more new schools.

The PMT is also responsible for processing Facilities Use Agreements and collecting Developer Fees. Over the past year, 367 (1,485 total) were processed for outside community groups wanting to utilize District facilities and over 200 revenue transactions took place to collect \$5.5 million in Developer Fees for capital projects.

On behalf of the Facilities Management Department, I am pleased to present this Facilities Capital Improvement Program Annual Report for Fiscal Year 2007–2008. The purpose of this document is to provide an overview of the progress made and the current status of the District's Facilities Capital Improvement Program between July 2007 and July 2008. Progress information is also available on our Facilities web site at <a href="https://www.sbcusdfacilities.com">www.sbcusdfacilities.com</a>.

This report marks the completion of over 40 projects that began in early 2006 valued at over \$190 million. Completed projects include Rodriguez Prep Academy, the new Curtis Middle School, Bing Wong Elementary School, Special Day Classroom buildings at 12 schools, the modernization of 6 campuses and a variety of other facilities projects including stadiums, lunch shelters and kitchen upgrades.

Of special note this year is state approval status as a financial hardship district. This is an integral component of the District's Facilities Master Plan to secure funding for much-needed schools in support of the District's long term goal to reduce over-crowding and provide a single track school year to all students. Financial hardship status secures \$363 million in state funds for design and real estate acquisition for 8 new schools, construction of a new high school, construction of 8 Special Day Classroom buildings, and modernization work for 37 schools.

modernizations. The completion
of these major projects marks the end
of the first phase of the Facilities Capital

Planned for the next phase of the program is \$363 million of work for 54 projects, including construction of one new high school, design and land acquisition for 8 new campuses, modernization of 37 schools and construction of 8 Special Day Classroom buildings at elementary schools.

# **Active and Completed Projects**



Curtis Middle School, August 2008

This section contains the final update to the \$190 million phase of construction of over 40 projects which are now complete. Under construction since Fall 2006, three new schools are now complete and ready for students' first day of school in August 2008. Also in the Fall of 2006, staggered construction of 10 Special Day Classroom (SDC) buildings started. Due to the facilities business outreach efforts, increased competitive bidding resulted in cost savings to allow construction of an additional 2 SDC buildings. All 12 SDC buildings completed construction the summer of 2008. Similarly, 5 modernization projects were bid under budget allowing for one more modernization to be added to the construction schedule. The 6 modernization projects are substantially complete.

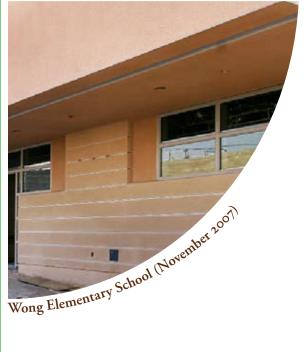


# **New Campus Projects**

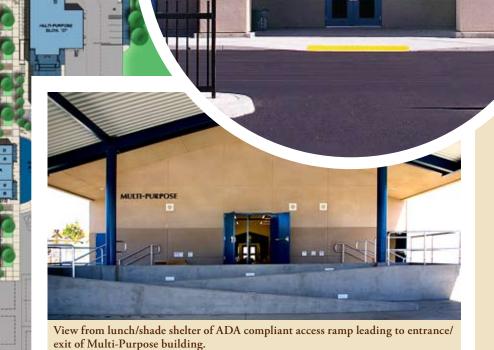

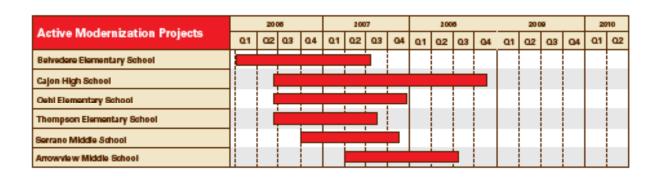




# **Modernization Projects**

Major modernization of six schools valued at about \$43 million that started in 2006 is now subtantially complete at Belvedere, Oehl and Thompson Elementary Schools, Serrano and Arrowview Middle Schools. The largest modernization project, at Cajon High School, is expected to be complete by Winter 2008. Modern learning upgrades include: teacher learning walls, e-rate data and communications systems, remodeled student theatre and libraries, and locker room and gym facilities.

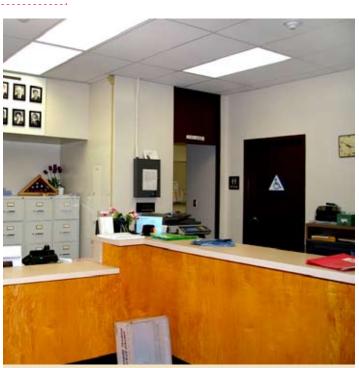

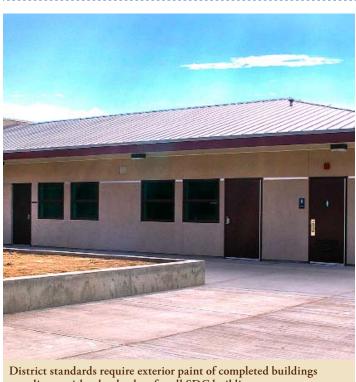

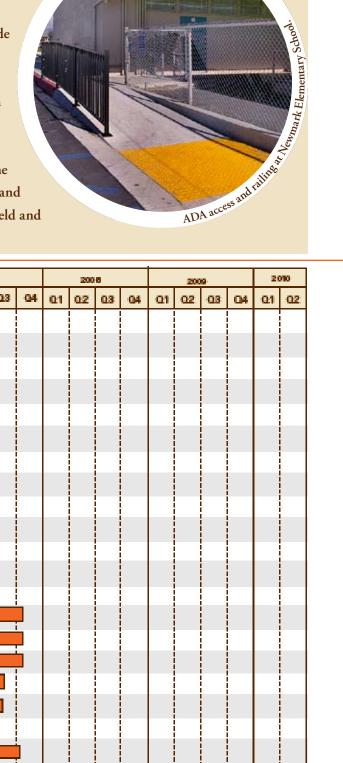

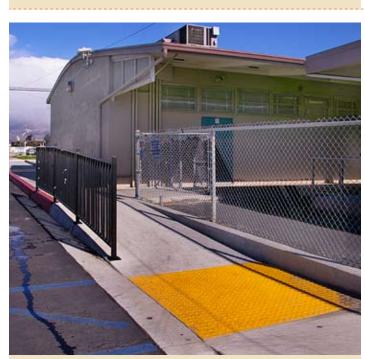

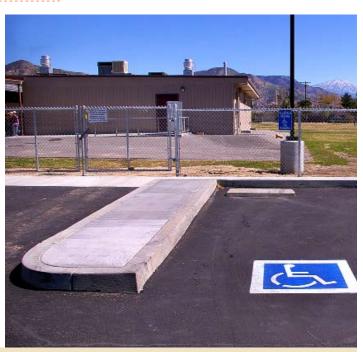

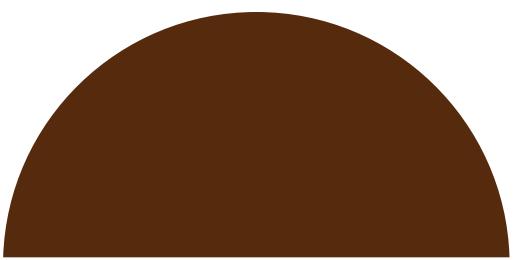

# **Planned Projects**



Special Day Classrooms (SDC), San Gorgonio High School

This section introduces the Facilities Capital Improvement Program's next phase of construction with the first of 54 planned projects scheduled to start Fall 2008. State financial hardship funding in the amount of \$363 million received this fiscal year will be used for design/land for 8 planned campuses, construction of one new high school and 8 Special Day Classroom buildings, and modernization work at 37 schools.



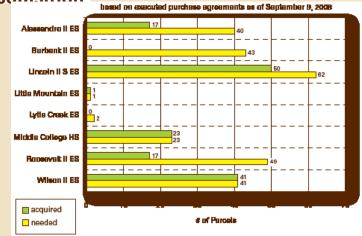
# **Financial Hardship**

Projects funded through the State Financial Hardship Program are restricted to essential facilities or the basic capital improvements necessary to function as a school. On May 13, 2008, the District received approval from the Office of Public School Construction for Financial Hardship status. The Facilities Management Department has filed a total of over \$363 million in Financial Hardship funding applications and has • 1 Project Construction: received \$169.9 million in funds to date.

# **Challenges**

The Facilities Department faces a number of challenges to deliver new schools and upgrade existing campuses. School Districts fund capital projects with State Bonds, Local Bonds, Developer Fees and Donations. As the State and local economies continue to be tempered in recent years, construction funding is becoming more difficult to secure.

#### **State Funding**

The recent State budget woes impact school construction funding as the State imposes stricter regulations to distribute declining State bond funds for schools. The State does not provide sufficient funding to construct a minimum essential facility to house students and the State expects its bond funds for new construction to be exhausted in 2009. There is no State bond measure on this upcoming November 2008 ballot and the next window to place bonds on the ballot will be in 2010.

#### **Local Economy**

Combined with the dwindling State bonds is a shortage of local bond funds to provide District matching dollars. The local decline in housing and development is reflected in fewer Developer Fees collected by the District to provide additional funds for school projects. All these shortages in funding translate into budget shortfalls to complete school projects.

#### **Repairs and Upgrades**

The District also has additional needs beyond the Planned Projects in this section of the report. Over the past year, the Facilities Department conducted a district-wide survey of all existing schools to evaluate the need for repairs and upgrades. Over 1,500 needs were identified in these surveys which represents over \$800 million in additional project needs.

#### **Local Funding**

The Facilities Department will be evaluating funding options that include the possibility of issuing a local bond in 2010, issuing Certificates of Participation, or building less than minimum essential facilities to address budget shortfalls and to provide the necessary repairs and upgrades at existing schools.

# **New Campus Projects**

Of the \$216.7 million in funding for 8 new schools, \$53.8 million is for construction of one new high school and \$162.9 million is for design and site apportionment for 8 sites. The chart on page 30 tracks the acquisition of real estate parcels for those 8 sites. The schedule bar chart below for Curtis High School indicates the timeline for construction. The construction of the 8 campuses will depend on acquisition of real estate, agency approvals, and funding.

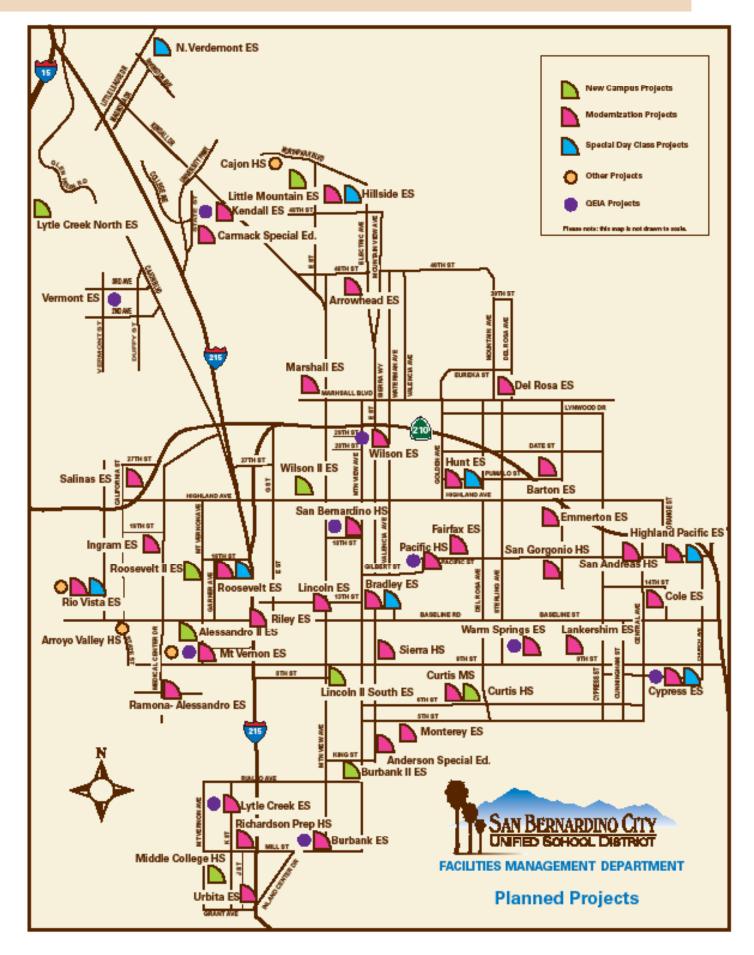

# California Environmental Quality Act Requirements

As part of the due diligence process for planning, locating and designing new school facilities, requirements for the California Environmental Quality Act (CEQA) must be met. CEQA mandates public agencies to review the environmental impacts of proposed projects, to prepare and review environmental impact reports (EIRs), negative declarations, and mitigated negative declarations, and to consider feasible alternatives and mitigation measures that would substantially reduce significant adverse environmental effects.

To this end, a scoping meeting was held for Wilson Elementary School II in early 2007. A recent public hearing in January 2008 was held to receive comments on the draft environmental impact report (EIR) for this project. Numerous comments were received from the public at both hearings which were formally advertised in conjunction with several thousand notices sent home with students and mailed to affected homeowners. During a regular Board of Education meeting on May 6, 2008, Wilson II Final EIR, Statement of Overriding Considerations and Mitigation Monitoring Plan were approved. A Notice of Determination for Wilson II was filed with County on May 8, 2008.

For the Lincoln II Elementary School site, public hearing to receive comments on the draft EIR was scheduled for February 2008. A public hearing before the Board of Education was scheduled for each project to approve the final EIR. During a regular Board meeting on May 6, 2008, Lincoln II Final EIR, Statement of Overriding Considerations and Mitigation Monitoring Plan were approved. A Notice of Determination for Lincoln II was filed with County on May 8, 2008.

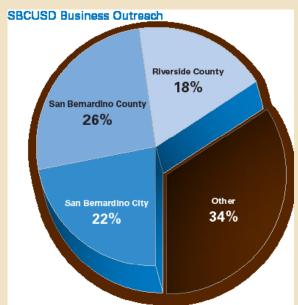
A mitigated negative declaration (MND) has been prepared and distributed to the required review agencies for the Little Mountain Elementary School, Middle College High School and Roosevelt II Elementary School projects. General public was also given the opportunity to review documents; copies were made available through local libraries, BOE and Facilities website. Little Mountain and Middle College MNDs were adopted by the Board of Education during a regular session on March 16, 2008. A Notice of Determination was filed with County on March 20, 2008. Roosevelt II MND was adopted by the Board of Education during a regular session on March 4, 2008. Notice of Determination for Roosevelt was filed with County on March 6, 2008.



# Over 40 Local Businesses Attend Facilities Second Annual Open House

The Facilities Local Business Outreach Program held its second annual Facilities Department Open House in March 2008. Project and program managers met with over 40 vendors, contractors and consultants and talked about upcoming opportunities to work with the District on the second phase of its capital improvement program that includes 54 projects totaling over \$363 million. Work includes formal and informal bids.

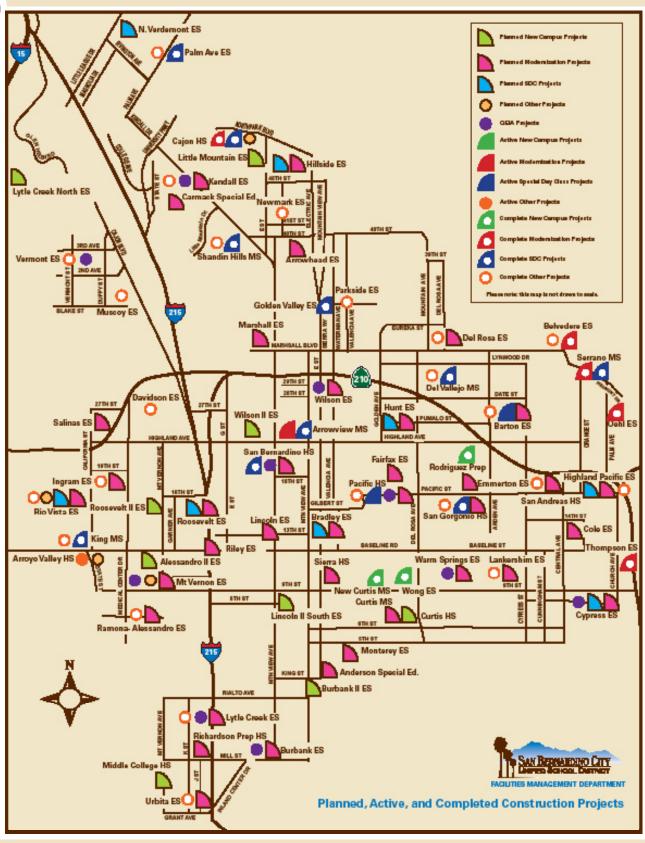
# Facilities Business Outreach Program Increases Local Competition, Keeps Dollars Local
