2. Administrative Report

a. December Monty Briefing

Laura briefly discussed the Briefing which highlighted the progress of our new campus construction which includes the demolition of acquired property as well as the progress at Indian Springs. Also covered in the Briefing are the 11 modernization project that are currently underway.

b. Lease-Lease Back Presentation – Wael Elatar

Wael discussed the lengthy process the district goes through to obtain bids for projects and proposes the use of Lease-Lease Back process for upcoming Middle College HS, Little Mountain, and the ORG project which include Lincoln, Wilson, Lytle Creek, Lankershim, Muscoy, and Vermont. The process of Lease-Lease Back allows the district to build these designed projects with sole source DSA approved buildings without requiring Board approved sole source resolutions. This would provide the district with a good "head start" on not to exceed state funding issues. If construction deadline dates are not met the district would be as risk of paying back much needed state funds. The Lease-Lease Back process was used to construct the San Gorgonio Sports Stadium. Essentially the district would lease the land/property for \$1.00 per year to the construction company to perform the work and upon the completion of the project the construction company would lease it back to the district. The construction companies would be paid by percentage of work completed throughout the construction process. This process would help save the district time as well as much needed funds.

c. March – December 2010 Funding Update – Laura Breuer

Laura provided a spreadsheet with information on all the expenditures for the period March – December 2010 totaling \$3,586,726.91. Laura also provided pie charts showing the impact of the expenditures by funding sources as well as by project/school.

d. Bus tour Overview - Kathy Haskins

An overview of the bus tour that took place on September 1, 2010 was provided for the members to read over in lieu of meeting minutes.
