

## NOTICE INVITING BIDS

**NOTICE IS HEREBY GIVEN** that the **San Bernardino City Unified School District** (“**DISTRICT**”) invites sealed bids for **Classroom Additions at Muscoy and Vermont Elementary Schools Bid # F12-01**.

**SUBMITTAL OF BIDS:** All bids shall be made on the Bid Forms furnished by the District. Bid Forms, together with all required attachments to the Bid Forms, shall be delivered to the DISTRICT **in a sealed envelope with a copy of the completed required bid cover sheet affixed to the outside of the envelope** and placed in the **Bid Box** in the **Lobby** of the **San Bernardino City Unified School District Board of Education Administration Building**, located at **777 N. F Street, San Bernardino, CA 92410**. The Bids are due no later than **2:00 P.M. on August 9, 2012**.

Bid forms received by the stipulated time will be promptly opened in public and read aloud immediately after sealed envelopes are collected at the time, date, and location stated above. Bid Forms or Attachments thereto received after the stipulated time will be rejected and returned to Bidders unopened. Each Bid shall be accompanied by a cashier's check made payable to the San Bernardino City Unified School District, or a satisfactory bid bond in favor of the DISTRICT, executed by the Bidder as principal and a California admitted surety company as Surety, in an amount not less than ten percent (10%) of the Base Bid submitted by the Bidder.

**BID AND CONTRACT DOCUMENTS:** The full notice inviting Bids, Bid documents and contract documents may be viewed and ordered through **C2 Reprographics PlanWell Service** online by clicking on ‘**Public Planroom**’ at [www.c2repro.com](http://www.c2repro.com) beginning Monday July 15, 2012. There is a **refundable** deposit of **two hundred dollars (\$200.00)** for each site set or \$400 for both sites, upon payment by cashier's or company check made payable to **San Bernardino City Unified School District**. Prospective Bidders may secure up to **two bid sets**. Bidders in need of more than two sets of bid documents may purchase additional sets (only if available) for **\$200.00** each site set. The charge for additional sets is non-refundable. **PROJECT DELIVERY METHOD AND REQUIRED LICENSES:** The work under these bids will be a GENERAL CONTRACT bid and all bidders to be considered responsive shall have a current California "B" License with CAL/OSHA certification.

**SCOPE OF WORK:** The general contractor is responsible for the performance and completion of all items according to plans, specifications and any addenda including but not necessarily limited to:

(1).Construction of a two story DSA Pre-Checked ("PC") 12 classroom building and two (2) single story Pre-Checked modular kindergarten buildings complete with related site work and utilities at the existing Vermont Elementary School, 3695 Vermont Street, San Bernardino CA 92407 and (2) : Construction of a two story PC classroom building and a one(1) single story PC site-built kindergarten building complete with related site work and utilities at the existing Muscoy Elementary School, 2119 Blake Street, San Bernardino,, CA 92407.
