

NOTICE INVITING BIDS

NOTICE IS HEREBY GIVEN that **SAN BERNARDINO CITY UNIFIED SCHOOL DISTRICT** invites sealed bids for the **Soil Remediation, Abatement and Demolition Services (Bid #F09-11) at the New Roosevelt II Elementary School (Dr. Mildred D. Henry Elementary School) Site.**

SUBMITTAL OF BIDS: All bids shall be made on a Bid Form furnished by the DISTRICT. Bid Forms, together with all required attachments to the Bid Form, shall be delivered to the DISTRICT **in a sealed envelope with a copy of the completed required bid cover sheet affixed to the outside of the envelope**, and placed in the **Bid Box** in the **Purchasing Department** of San Bernardino City Unified School DISTRICT, 777 North "F" Street, San Bernardino, CA 92410, not later than **4:00 p.m. on Wednesday, May 26, 2010**. Bid Forms received by the stipulated time will be promptly opened in public and read aloud at the time, date and location stated above. Bid Forms or Attachments thereto received after the stipulated time will be rejected and returned to BIDDERS unopened. Each bid shall be accompanied by a cashier's check made payable to the DISTRICT, or a satisfactory bid bond in favor of the DISTRICT, executed by the BIDDER as principal and a California admitted surety company as Surety, in an amount not less than ten percent (10%) of the Base Bid submitted by the BIDDER.

SCOPE OF WORK: Soil remediation, abatement, demolition and removal of the building and structures on residential parcels in the City of San Bernardino for the construction of the New Roosevelt 2 Elementary School.
