

NOTICE INVITING BIDS

NOTICE IS HEREBY GIVEN that **San Bernardino City Unified School District** invites sealed bids for the construction of **Inghram and Lytle Creek Elementary School, Richardson and , Serrano Middle School Miscellaneous Modernizations (Bid #F11-05)**.

SUBMITTAL OF BIDS: All bids shall be made on the Bid Form furnished by the DISTRICT. Bid Forms, together with all required attachments to the Bid Form, shall be delivered to the DISTRICT **in a sealed envelope with a copy of the completed required bid cover sheet affixed to the outside of the envelope**, and placed in the **Bid Box** located in the **Lobby of San Bernardino City Unified School District Office, 777 North F Street, San Bernardino, CA 92410**, not later than **10:30 am on Thursday, May 10, 2012**. After receipt of Bid Forms by the stipulated time, they will be promptly opened in public and read aloud at the time, date and location stated above. Bid Forms or Attachments thereto received after the stipulated time will be rejected and returned to BIDDERS unopened. Each bid shall be accompanied by a cashier's check made payable to the DISTRICT, or a satisfactory bid bond in favor of the DISTRICT, executed by the BIDDER as principal and a California admitted surety company as Surety, in an amount not less than ten percent (10%) of the Base Bid submitted by the BIDDER.

BID AND CONTRACT DOCUMENTS: The notice inviting bids, bid documents and contract documents may be viewed and ordered through **C2 Reprographics' PlanWell Service** online by clicking on '**Public Planroom**' at **www.c2repro.com**. There is a **non-refundable** deposit of **fifty dollars (\$50.00)** for the first set, cashier or company check made payable to **San Bernardino City Unified School District**. PROJECT DELIVERY METHOD AND REQUIRED LICENSES: The work under this bid is a **General Contractor constructed** project of the **Facilities Management Department**. Licenses required are as follows:

The General Contractor is responsible for the performance and completion of all items in the Summary of Work Section 01010.

SCOPE OF WORK: Inghram and Lytle Creek Elementary School, Richardson and Serrano Middle School Miscellenous modernizations (Bid #F11-05). Per Summary of Work Section 01010, the scope of work shall include but not be limited to:

The project includes miscellaneous scopes of work including site accessibility path-of-travel improvements, entry door and site gates/hardware upgrades, plumbing fixture adjustments associated with accessibility, limited fire alarm upgrades, lunch shelter painting (intumescent paint), limited casework/cabinetry modifications, specific structural wall framing upgrades and site restoration improvements where modular buildings are being removed .

The full scope of work for each site is contained in the bidding documents, which may be viewed and ordered through **C2 Reprographics**' Plan Well Service.

GOALS AND REQUIREMENTS: BIDDERS must adhere to the District's Disabled Veteran Business Enterprise (DVBE) participation goal, prevailing wages and labor compliance program, and license requirements. PRE-BID CONFERENCE AND JOB WALK: A **Non-Mandatory Job Walk** will be held at the site by representatives of the DISTRICT and its Architect for attendance by any interested BIDDER. **The walk** will commence at **9:00 am, Friday, April 27, 2012 at the Richardson Prep High Middle School site** located at **455 South K Street, San Bernardino, CA 92410**. All potential CONTRACTORS planning to submit a bid for the project **ARE ENCOURAGED** to attend the job walk to become familiar with the conditions of the jobsite and the project requirements; as well as to have the opportunity to request additional information.

BASIS OF AWARD: Consistent with Public Contract Code Section 20103.8 and Section 12D of the "Information for Bidders" relating to the use of alternate bids, the lowest responsible BIDDER for the project will be determined using the following method:

1. The lowest Bid shall be the lowest Base Bid without consideration of the prices on the additive or deductive alternates.

2. Once the lowest responsible BIDDER has been selected, the DISTRICT may determine to add to or deduct from the Contract one or more of the additive or deductive items.

The DISTRICT reserves the right to reject any or all bids and to waive irregularities in any bid.
