- 1. Is Demographics to be considered part of the proposal, or does the District have a contract with a Demographics consultant already?
 - A1. No; demographics is not to be a part of the Scope of Work.
- 2. Is it the anticipation of the District to go out for a future bond?
 - A2. While a future bond is a possibility, the District has not yet made a decision on that option.
- 3. Does proposing or being selected as the Master Plan Architect exclude us from design for future projects listed under the master plan?

A3. No

- 4. On the last page of the RFP (Page 22 Excluded Services) it lists site selection, however on page 20, there is a section titled site selection under Phase 3. Please clarify if it is in fact to be included or not.
 - A4. Site selection should be included as an optional service. Excluded Services on Page 22 has been revised and is attached to this document.
- 5. Please provide square footage of schools.
 - A5. See attached Exhibit D Buildings Square Footage.
- 6. Does the District want a needs assessment done at all 89 sites?
 - A6. The District has not yet decided to pursue assessments of all 74 school sites, or if the focus will be a subset of that total.
- 7. Are the attachments considered in the page count?
 - A7. Responses to Attachments 1 through 6 will not be included in the page count.
- 8. Is the district currently using a CMMS or work order system?
 - A8. Yes, the District uses an SAP work order system.

Services may include clarifying educational specifications to designers on future projects and performing third party reviews on future project designs to facilitate compliance to the District educational specifications and Master Plan initiatives.

Deliverables: Master Planning related support services as requested by District. These services would be performed on a Time & Materials basis.

SBCUSD does not envision requiring the following services:

- 1) Site selection for recommended new facilities
- 2) Available funding studies; analysis of tax base
- 3) Any work related to buildings not owned by the District
- 4) Evaluation of conditions concealed by construction
- 5) Destructive investigation
- 6) Materials testing
- 7) Condition inspection of underground utilities
- 8) Energy audits
- 9) Design services
