Once the CONTRACTOR has received the notice to proceed, the CONTRACTOR shall complete the work in the time specified in the Agreement. By submitting this bid, CONTRACTOR has thoroughly studied this Project and agrees that the time period for this Project was adequate for the timely and proper completion of the Project. Further, CONTRACTOR has included in the analysis of the time required for this Project, Rain Days, Governmental Delays, and the requisite time to complete Punch List.

In the event that the DISTRICT desires to postpone giving the notice to proceed beyond this ninety (90) day period, it is expressly understood that with reasonable notice to the CONTRACTOR, giving the notice to proceed may be postponed by the DISTRICT. 15. The bidder declares that he/she has carefully examined the location of the proposed work, that he/she has examined the Contract Documents, including the Plans, General Conditions of the contract, Supplemental Conditions, Addenda, and Specifications, all other documents issued to bidders and read the accompanying instructions to bidders, and hereby proposes and agrees, if this proposal is accepted, to furnish all materials and do all work required to complete the said work in accordance with the Contract Documents, in the time and manner therein prescribed for the unit cost and lump sum amounts set forth in this Bid Form.

RFIs F19-08 District-Wide Marquee New Installation, Relocation, and Refurbishment

1. Please specify what video input source is needed.

District Response: The District does not wish to limit the capabilities of the existing systems that may be unique at each school site. We anticipate a variety of video input options district-wide.

2. Can school IT provide multimode fiber patch from the proposed sign location to the control room?

District Response: Yes, the District has the capability of installing fiber cables, however, a line item has been added to the Bid Form to address fiber installations.

3. Will we be limited to using the three (3) Name Brand American suppliers of the LED message boards as we were on the last bid? The three were Watchfire, Optec, and Daktronics, or are we allowed to substitute Chinese made or "off brand" LED Message Boards? I believe you are using Optec units now.

District Response: The District expects a quick response when making repairs or addressing an outage. Replacement parts should be quick and easy to access to allow repairs to be made in a timely manner.

4. How long is the expected warranty period on the LED boards themselves?

District Response: 36 Months

5. Will the LED message boards be hardwired for communication as you normally do? Did you want to go with a cellular modem?

District Response: The revised Bid Form found in Addendum No. 1 reflects a line item for cellular modem communication, WIFI, as well as hardwired communication.

6. Do you have any drawings or plans for the pirate logo, and exposed double tube and single tube neon?

District Response: No, we do not have any drawings or plans for the pirate logo and new neon. This is an item that will need to be discussed with the site

administration prior to implementation. The existing marquee is located at Pacific High School and can be viewed from the property line for reference.

7. Do you have a location that the neon marquee will be relocated to?

District Response: The existing marquee is within the boundaries of new construction and will need to be relocated, however, the new location has not been determined and will need to be discussed with the site administration prior to relocation. The marquee will be reinstalled on new posts in a new location.

8. On all locations will the district bring power and data within 10ft. of the new sign locations?

District Response: District personnel will bring power and data to within 100 ft of the new sign locations, however, we will make every attempt to bring power and data to within 10ft. of the locations.

9. Can you please provide the cost estimate/budget for the project?

District Response: A project cost estimate has not been developed for this project.

10. I would like to clarify the licensing requirement for the project.

“PROJECT DELIVERY METHOD AND REQUIRED LICENSES: The work under this bid will be a unit price bid and all bidders to be considered responsive shall have a current California B and/or C45 License.”

Does this mean that a C45 license is required even if a B license is held? B and C45?

District Response: To clarify, the intention is that the contractors hold a California B and/or a C45 license. The contractor can hold either or both.
