REQUESTED CLARIFICATION:

1. Can you please confirm that the chain link wire is knuckled top and twist bottom, typically all schools are knuckled top and bottom

2. The specs call out for 2-1/2" mesh which is extremely custom and most likely a typo, typically all schools are 2" mesh or 1" mesh, please clarify.

3. (2) Major conflicts with the wire with a 2.0oz zinc (GAW) Galvanized After Weave vinyl coated Black. #1 Is that the wire is vinyl coated Before weaving (GBW). GBW is the industry standard especially for weaving. Can we use GBW instead of GAW?

#2 2.0oz zinc fuse bonded vinyl coated fencing fabric is custom, the standard is 1.2oz zinc. Can we use 1.2oz instead of 2.0oz?

Please note: Most suppliers will not supply 2.0oz GAW wire especially to schools due to the high liability of icicles.


