For future District projects, any successful contractor(s) shall be required to furnish a 100% Performance Bond and a 100% Payment Bond if awarded a contract. On those projects, contractor(s) and its subcontractors shall pay all workers not less than the general prevailing rate of per diem wages and the general prevailing rate for holiday and overtime work as determined by the Director of the Department of Industrial Relations, State of California, for the type of work performed and the locality in which the work is to be performed within the boundaries of the District, pursuant to sections 1770 et seq. of the California Labor Code. Prevailing wage rates are available from the District or on the Internet at: http://www.dir.ca.gov. Contractors shall comply with the registration and qualification requirements pursuant to sections 1725.5 and 1771.1 of the California Labor Code.

On February 4, 2025, the District's Board of Education approved a Community Workforce Agreement ("CWA") with the San Bernardino – Riverside Building and Construction Trades Council and the Signatory Craft Councils and Unions. The CWA does not dictate the project delivery method, nor does it preclude any project delivery method. If the District elects to use a contractor from the lease-leaseback pool for any project identified in the CWA, please note that the terms of the CWA will apply. The District encourages all firms interested in submitting a proposal in response to this RFP to review the terms of the CWA.

If the District issues addenda to this RFQ/P, contractors are solely responsible for and must acknowledge receipt of addenda in their response.
